- After May 14: Fees increase by \$15

DETAILS

Directions: From Hwy 97 from La Pine. One mile south of La Pine, past mile post 169, turn east onto Hwy 31. Go to mile post 25 and look for the flagged and signed left turn to Outback Station.

Camp: A large meadow with easy parking for big rigs. Located off well traveled paved and gravel road.

Corrals: Limited number of pens available. Pens will be awarded by lottery. See website for details.

Trail: USFS roads and trails. Some elevation change, no steep up or downs. Plentiful water on trail. This is an ideal first 100 miler for horse and/or rider.

Rules: All AERC rules apply

- Spread hay and manure
- Fill holes dug by your horses
- Clean your campsite prior to leaving
- HELMETS required when mounted for all riders
